

# PDF Signer — Terms of Service

Please read these terms carefully before using the App.

## 1. Acceptance of Terms

By downloading, installing, or using PDF Signer ("the App"), you agree to be bound by these Terms of Service ("Terms"). If you do not agree, do not use the App. These Terms constitute a legal agreement between you and Profit First LLC ("we", "us", "our").

## 2. Description of Service

PDF Signer is an iOS application that allows users to import PDF documents, add handwritten signatures, and export signed PDFs. The App operates entirely on-device. A Free plan and a Pro subscription plan are available.

## 3. Subscription & Billing

PDF Signer Pro is offered as an auto-renewable subscription:

### Subscription plans

- Weekly Plan: \$2.99 per week, billed every 7 days.
- Yearly Plan: \$19.99 per year, billed annually.

### Billing terms

- Payment is charged to your Apple ID account at confirmation of purchase.
- Subscriptions automatically renew unless cancelled at least 24 hours before the current period ends.
- Your account will be charged for renewal within 24 hours prior to the end of the current period.
- You may manage or cancel your subscription at any time via your Apple ID Account Settings.
- No refunds are provided for partial subscription periods, except as required by applicable law.

## 4. Free Plan Limitations

Users on the Free plan may export a maximum of one (1) signed PDF document. Signing and importing PDFs are unlimited for all users. To export additional documents, a Pro subscription is required.

## 5. User Responsibilities

You agree to use the App only for lawful purposes. You must not:

- Use the App to forge, falsify, or fraudulently create signatures on documents.
- Use the App to sign documents on behalf of others without proper authorization.
- Reverse engineer, decompile, or disassemble any part of the App.

- Attempt to circumvent subscription or payment verification mechanisms.

You are solely responsible for the legal validity and authenticity of any signatures created using the App in your jurisdiction.

## 6. Intellectual Property

All content, design, code, and assets within the App are the exclusive property of Profit First LLC and are protected by applicable intellectual property laws. You are granted a limited, non-exclusive, non-transferable license to use the App for personal or business purposes in accordance with these Terms.

## 7. Disclaimer of Warranties

The App is provided "as is" and "as available" without warranties of any kind, express or implied, including but not limited to warranties of merchantability, fitness for a particular purpose, or non-infringement. We do not warrant that the App will be error-free, uninterrupted, or that defects will be corrected.
